

THE LOSS OF SADNESS: IS NORMAL SADNESS BEING MISLABELED AS DEPRESSIVE DISORDER?

Jerome C. Wakefield, PhD, DSW is University Professor, Professor of Social Work, and Professor of Psychiatry, as well as Affiliate Faculty in Bioethics and in the Center for Ancient Studies, at New York University; and Lecturer in Psychiatry at Columbia University College of Physicians and Surgeons. He is author with Allan Horwitz of “The Loss of Sadness: How Psychiatry Transformed Normal Sorrow into Depressive Disorder” (Oxford, 2007). Dr. Wakefield is the author of over 150 publications appearing in journals in psychiatry, psychology, philosophy, psychoanalysis, and social work.
